

WHY YOU SHOULD ATTEND

We are on the precipitous of another massive shift in the Medicaid managed care program with the implementation of the BH/IDD Tailored Plan planned for December 1, 2022. This is the next step in transitioning North Carolina's Medicaid program to a system of managed, integrated whole person care. The BH/IDD Tailored Plan integrates behavioral health and substance use disorder, intellectualdevelopmental disability, physical health, pharmacy, care management and brain injury services for those with severe and persistent mental illness, I/DD and SUD needs under one program to be managed by NC's LME/ MCOs. The Standard Plan's integrated care for the mild to moderate behavioral health population began in July 2021.

Our theme this year, Critical Connections: People-Data-Care stems from the truth that as we move further along with integrated care, connections will be critical to success. This shift requires a true focus on people, with an essential need for data sharing that facilitates care integration. This theme will be woven throughout the sessions which will be led by national and state experts offering insightful information, updates and policy details designed to inform and guide leaders and stakeholder through these challenging times.

WHO SHOULD ATTEND?

Anyone in the NC Medicaid system that is managing, experiencing or providing care to the BH/IDD population who wants to better understand the new structures, partnerships and program collaborations needed to move services toward an integrated whole person care approach. 

Changing the I/DD LANDscape in North Carolina

In October 2021, the Leadership Alliance for Neurodevelopmental Disabilities (LAND) was awarded a four-year grant to help bring about systemic change for the I/DD community in North Carolina. This grant is getting at the needs of the individuals who are using services, their families and their natural supports and leveraging/coordinating resources to face the challenge of unmet needs. The initiative's name is "Meet the Need NC: Changing the I/DD landscape across the state." At the heart of the initiative is an Advisory Council of 40+ people representing a diverse group of communities across North Carolina. It includes self-advocates (those with developmental disabilities) and advocates (their families) representing a diverse list of developmental disabilities; and individuals from a cross section of NC Agencies, providers, nonprofits, researchers, healthcare professionals, and advocacy organizations. The initiative is using the Collective Impact model with diverse populations to develop and implement a Common Agenda to meet the goals of the grant. The presentation will focus on the benefits and challenges of using the Collective Impact model with diverse populations to affect change



Discuss the Collective Impact model as a way of bringing diverse groups together toward a Common Agenda, review the benefits and challenges of the Collective Impact model vs traditional planning methods, review the NCCDD LAND/Meet the Need NC grant as an example of using Collective Impact to achieve systemic change for the I/DD community in North Carolina; and review how the Meet the Need NC initiative is working to change the I/DD landscape across the state.

Lessons Learned from Epidemic to Pandemic

The Opioid epidemic has had an enormous impact nationwide. This session will explore the history, research and trends surrounding the opioid epidemic. We will look at lessons learned from everything from Epidemic to Pandemic to the ever-present overdose rates that we continue to wrestle with. Strategies for destigmatizing addiction and implementing proven treatment strategies will be explored, including the role of medications. There will also be discussion of the key reframes necessary for the field to move forward successfully - especially when it comes to finding the best utilization for opioid settlement and other related funding opportunities.



Provider Choice - How to Decide on Joining an ACO vs. CIN

This session will focus on the models of accountable care organizations specifically for the integration of behavioral health service providers. Health Risk-Informed Telemedicine: A Model for Improving Health Equity for People with I/DD

Equitable access to telemedicine and other healthcare services is a challenge for people with intellectual and developmental disabilities (I/DD) because most clinicians are not aware of the unique health risks that exist for this population. As a result, the health conditions most likely to result in morbidity and mortality are overlooked or misdiagnosed. This panel presentation highlights an innovative model and public/private partnership with the Missouri Division of Developmental Disabilities comprised of three key elements: online clinician education in I/DD healthcare, the use of web-based health risk-informed data, and I/DD competent telemedicine supports. Strategies for preventing unnecessary emergency department visits, promoting identification and diagnosis of often-missed health conditions, and addressing health disparities for people with I/DD will be explored.

Ensuring Seamless, Statewide Care for Foster Children: the NC Child and Family Improvement Initiative

North Carolina's six LME/MCOs launched the NC Child and Family Improvement Initiative on May 1, 2022, to create a statewide solution to the current pressing challenges of the service delivery system. In collaboration with local DSS agencies, service providers, and members of LME/MCO Consumer and Family Advisory Committees (CFACs), the Initiative has addressed the nine critical objectives identified as cornerstones of a statewide model to support seamless access to quality care for children in foster care regardless of where they live in North Carolina.

To date, the LME/MCOs have: created a statewide provider network; ensured a standardized, seamless process for children moving from LME/MCO regions and changing custody to a new DSS; developed a rapid access to care by reducing authorization barriers for residential treatment; increased capacity for crisis care across the state; co-located LME/MCO care managers across NC's County and regional DSS offices, established a standardized reimbursement rate; adopted standardized, child-specific In-Lieu-Of Services; developed a standardized, statewide referral system for all residential and Therapeutic Foster Care providers; and standardized coordinated response frameworks in collaboration with local DSS departments.

Achieving Healthy Generations in North Carolina's Indian Country

NC has approximately 180,000 tribal members in NC. This number represents both state and federally recognized tribal members. American Indians are disproportionately affected by many chronic conditions, including heart disease, cancer, diabetes, and stroke, as well as unintentional injuries (accidents). American Indians and Alaska Natives also have a high prevalence and risk factors for mental health and suicide, obesity, substance use, sudden infant death syndrome (SIDS), teenage pregnancy, liver disease, and hepatitis. This session will examine the systemic issues contributing to these higher health burdens and the role that providers, health plans and state agencies can play in changing these alarming trends for Indigenous People. Using the NC Medicaid Quality Framework, the session will highlight options specific for tribal populations in NC.

- Review health disparities in Native Americans in North Carolina and nationally
- Identify innovative programs found in Indian Country that are addressing health and social determinants of health

Enabling Better Healthcare Outcomes by Providing Targeted Solutions to Reduce Healthcare Disparities

Data is one of the keys to unlock our ability to address healthcare disparities. In this session, attendees will receive data-driven insights to changes occurring in communities of color because of the pandemic, the widening health disparities, and racial inequities in contracting. Speakers will provide a cross section of data from various disparity studies conducted in the past 2-3 years. The panelist will feature the experience of a psychiatrist working in this state for over 30 years who is also a person of color. She will share tools for the audience to apply in their own agencies, which will aid in closing the gap in health disparity.

Role of Behavioral Health Systems in Supporting Reproductive Health A-Z in the Tailored Plan Populations

Many Tailored Plan members have their primary connection to the healthcare system with their MH/SUD/I/DD providers. Building Bridges between Behavior Health and Brain Injury

Brain Injury is a complex, often chronic condition for individuals living with brain injury, but also their families and the community as a whole. Unemployment, economic instability, stigma, comorbidities, and other negative outcomes can be seen in the months and years after the injury. Lack of awareness and misattribution of symptoms is also common in individuals being served in the mental health, substance use, and developmental disability sector, potentially creating disruptors in comprehensive care. Tips for Revenue Cycle Success in NC Managed Care

Revenue cycle management needs to contain procedures to ensure that billing is timely and complies with payer contracts. Some providers can struggle with MCO reimbursement during Managed Care transition and this can continues long afterward. Thin margins in our industry magnify this impact. Denials prevent timely and complete payment, impacting cash flow and resource requirements in the Revenue Cycle department. The learning curve is often very difficult, especially when dealing with multiple payers with different systems and processes, and with claims and EVV aggregators. Appropriate up-front management of the Revenue Cycle can serve to minimize aggregator rejections and payer denials, thereby improving payments and required "re-touches" to get claims paid, and minimizing write-offs.



Review how home care and I/DD providers working with managed care organizations to obtain the highest percentage of billing in the shortest timeline, review how to ensure claims are as clean as possible, and discuss how to make claims follow-up consistent and timely.

Capacity Restoration: Current Forensic Services for Mental Health Defendants in North Carolina and Future Innovations

The team will outline the current services for forensic defendants in the state including options for the initial forensic assessment for capacity to proceed, current statutes that guide the process, and treatment options for capacity restoration. Implementing Olmstead: An Update and Conversation

Secretary Kinsley will open this session by addressing the Department's three priorities: investing in behavioral health and resilience, addressing child and family well-being, and building a strong and inclusive workforce. Real Life Lessons - Evaluating the Tailored Care Management Model

Care management is critical to coordinating and providing whole person care under the Tailored Plan. In this session, Partners Health Management will discuss how they assessed their Tailored Care Management (TCM) Model, looking at the training of provider organizations, the readiness assessment and implementation process, and a research study that was completed to assess its effectiveness. The TCM synthesized evidence-based approaches, e.g., the Collaborative Care Model, and was implemented over 14 months with ten provider organizations in the Partners Health Management catchment area. A quasi-experimental research design compared the Intervention Group and Comparison Group on key outcomes, e.g., cost and hospitalizations. The groups were paired on key factors using a Propensity Score Matching (PSM) process. Care Managers were embedded with each provider organization to implement the model, support fidelity, train staff, and collect data for research. Findings on outcomes, fidelity, qualitative methods, and process evaluation will be discussed.

DHHS Innovations in Complex Care Management

Since 2012, North Carolina DHHS, in partnership with six Local Management Entities (LMEs) and in compliance with a United States Department of Justice Settlement Agreement, developed a system of housing, services and supports, and community integration that is now known as Transitions to Community Living (TCL). Despite having over 3000 TCL participants transition into our communities, many people's transition were delayed due to complex medical and functional treatment needs, following years of institutional care. To address these significant community transition barriers, NC DHHS and its LME/MCO partners implemented a program called Complex Care Management. This care management model utilizes the joint assessment, consultation, and active monitoring by registered nurses, and for the first time, occupational therapists, who are employed by each LME/MCO. This innovative Complex Care Management model gathers and informs the person's care team and service planning during pre-transition in the facility and assures continual complex medical and functional services are sustained well after community transition.

- Review complex care planning, service acquisition, and onsite monitoring in this care management model
- Discuss how to develop the personal care, home health, and other specialty in-home medical service networks


