# ELECTIONS ARE OVER: PROJECTING TOP TRENDS FOR BEHAVIORAL HEALTH AND I/DD SERVICES

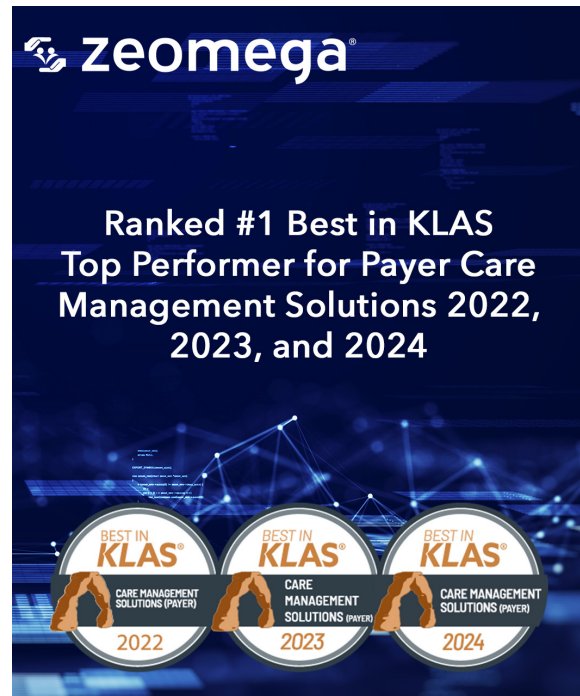
